Some decline (up to 8%) in the trend in current smoking prevalence among men population was observed since submission of the last report.
Among men, a significant decline (up to 2.5 time) was observed in non-daily smoking indicators since submission of the last report.
As the prevalence was almost 100 times higher for men than for women, the possibility on underreporting among female cannot be excluded. Therefore, data in "FEMALES" and "TOTAL" need to be interpreted with caution.
