Answers to B11: Smoking prevalence in the adult population (all)*

For the Federation of BiH:
Males: Current smokers (46,3%), Daily smokers (55,5%). Average number of the most-consumed smoking tobacco product used per day: 14,8.
Females: Current smokers (31,6%), Daily smokers (55,8%). Average number of the most-consumed smoking tobacco product used per day: 18,2.
Total (males and females): Current smokers (44,1%), Daily smokers (55,6%), Occasional smokers (15,7%). Average number of the most-consumed smoking tobacco product used per day: 16,9.
There were no new surveys since submission of the Report for 2018.

For the Republic of Srpska:
Males: Current smokers (37,5%), Daily smokers (35,9%), Former smokers (22,3%). Average number of the most-consumed smoking tobacco product used per day: 20.
Females: Current smokers (25,5%), Daily smokers (22,5%), Former smokers (9,3%) Average number of the most-consumed smoking tobacco product used per day: 20.
Total (males and females): Current smokers (31,0%), Daily smokers (28,7%), Former smokers (15,3%).

*Considering that the Study and the Survey were conducted in two different periods, although the same methodology was used in both entities, the Federation of BiH and the Republic of Srpska, it was not possible to consolidate the data presented above.

Brcko District BiH data are not included and there is a need for their inclusion in the next research.

No changes in the trends in Federation BiH and Republic of Srpska since submission of the last Report as last smoking prevalence surveys in adult population were performed in 2012 (Federation BiH) and 2011 (Republic of Srpska).

The Decision of the ITA Governing Board on the determination of specific and minimal excise tax on cigarettes and excise duty on smoking tobacco for 2018 („Official Gazette of BiH“, No. 84/17) defined that from the 1st January 2018 specific excise will be paid in the amount of 1,50 BAM for a package of 20 pieces while the excise tax on smoking tobacco will be increased from 96,80 BAM/kg in 2017 to 104,00 BAM/kg in 2018.

The Decision of the ITA Governing Board on the determination of specific and minimal excise tax on cigarettes and excise duty on smoking tobacco for 2019 („Official Gazette of BiH“, No. 75/18) defined that from the 1st January 2019 specific excise will be paid in the amount of 1,65 BAM for a package of 20 pieces while the excise tax on smoking tobacco will be increased from 104,00 BAM/kg in 2018 to 114,40 KM/kg in 2019.

Federation of Bosnia and Herzegovina:

The new Proposal of the Law on the Control and Restricted Use of Tobacco, Tobacco Products and Other Smoking Products was discussed and adopted by the Government of the FBiH in June 2018. It was forwarded to the Parliament of the FBiH for further parliamentary procedure. This Proposal of Law is partially in conformity with Directive 2014/40/EU, Commission Directive 2014/109/EU and Directive 2003/33/EC as well as the Framework Convention on Tobacco Control, ratified by BiH.

In order to protect and improve the health of the population, the Law regulates measures to prohibit and restrict the use of tobacco, tobacco products and other smoking products, prohibit their advertising, promotion and sponsorship, prohibit minors' approach to these products. According to the Constitution of Bosnia and Herzegovina, which is the integral part of the General Framework Agreement for Peace in Bosnia and Herzegovina (Annex 4), Bosnia and Herzegovina consists of two entities: the Federation of Bosnia and Herzegovina and the Republic of Srpska. The area of Brčko was settled through international arbitration after the Dayton Peace Agreement, and the Brčko District BiH was established in March 2000, with powers largely similar to those entities. Jurisdictions of Bosnia and Herzegovina are prescribed by Act III of the Constitution of Bosnia and Herzegovina: foreign policy, foreign-trade policy, tariff policy, monetary policy, as stated in Act VII; financing of institutions and international obligations of Bosnia and Herzegovina; politics and regulations concerning immigrants, refugees and asylum; conducting international and inter-entity criminal-justice regulations, including relations with Interpol; forming and functioning of mutual and international means of communication; traffic regulations among entities; air traffic control. All state functions and jurisdiction belong to the Republic of Srpska, except those that are clearly defined to the Bosnia and Herzegovina.

Organization and financing the health care is under responsibility of the Federation of Bosnia and Herzegovina, the Republic of Srpska and the Brčko District of Bosnia and Herzegovina.
