B115. Please provide a brief explanation of the trend in smoking prevalence in the adult population in the past two years or since submission of your last report.  
Los datos aportados por la Oficina de Prevención del Consumo de Tabaco son los publicados en la Encuesta Nacional de Salud 2016-2017, del Ministerio de Salud de Chile. y corresponden al capítulo- Consumo de Tabaco En la actualidad estos datos están siendo analizados para completar el proceso de información, por lo cual no podemos informar todos los datos solicitados. No obstante lo anterior la ENS 2009-2010 arrojó una prevalencia del consumo de tabaco de 40.6%,( H 44.2% M 37.1%) lo que indicaría una disminución significativa de un 7.3%  
En base a los estudio de Prevalencia Consumo de Tabaco en Población General elaborados por el Servicio Nacional para la Prevención y Rehabilitación del Consumo de Drogas y alcohol. (SENDA 2016)  
Los resultados confirman lo observado en la medición anterior, por cuanto las declaraciones sobre uso diario de tabaco permanecieron estables respecto a 2014 y 2012 (22,7% en 2014 a 21,2% en 2016), deteniéndose así la tendencia a la baja observada entre 2002 y 2012.  
La desagregación por sexo revela un descenso significativo de 2,5 puntos porcentuales en la prevalencia de consumo diario en mujeres en relación a 2014. La brecha observada por sexo en 2016 es estadísticamente significativa: 22,7% en hombres frente a 19,7% en mujeres.  
La desagregación por nivel socioeconómico muestra que la prevalencia de “consumo diario” de tabaco en el NSE Bajo (26,5%) es significativamente mayor que la reportada en el Medio (20,6%) y Alto (19,2%). No se registran variaciones estadísticamente significativas respecto a 2014 por nivel socioeconómico.

Estableciendo que en el grupo de 20 a 29 años se observa diferencia estadísticamente significativa de la ENS 2016-2017 y ENS 2009-2010. En los grupos de 15 a 19 años y el grupo de 65 años y más se observa diferencias estadísticamente significativa en relación al resto de grupos de edad.

En base al estudio de Prevalencia Consumo de Tabaco en Población elaborado por el Servicio Nacional para la Prevención y Rehabilitación del Consumo de Drogas y alcohol. (SENDA 2015)

Según tramos de edad, solo el descenso observado entre 45 y 64 años es estadísticamente significativo respecto al estudio anterior: de 49,5% en 2014 a 44,1% en 2016; en el resto de los tramos si bien existen variaciones, éstas no son estadísticamente significativas.
