La part de ceux qui déclarent avoir fumé au cours des 30 derniers jours, baisse dans les mêmes proportions. Bien que le recul soit un peu moins marqué en matière de tabagisme quotidien (- 7 points), un quart des adolescents disent fumer tous les jours, contre un tiers en 2014 (25,1 % vs 32,4 %). Ces diminutions se révèlent davantage le fait des filles, dont la consommation quotidienne a baissé de 25 % entre 2014 et 2017 contre 20 % chez les garçons. Néanmoins, les filles demeurent légèrement plus nombreuses à avoir expérimenté le tabac (59,9 % vs 58,1 % parmi les garçons).
