A systematic survey has not been conducted after the STEPS survey in 2011. However, trends in the Global Youth tobacco survey from 2007 to 2011 show rising trends. Therefore it is suspected that smoking rates are rising, particularly among youth and women.. Meanwhile, Water-pipe is being promoted heavily as traditional among locals (particularly adolescents and women) and tourists. There seems to be a rising trend in water-pipe use. It is hoped to get updates of trends from the ongoing Demographic Health survey.

Meanwhile, Water-pipe is being promoted traditional among locals (particularly adolescents and women) and tourists. There seems to be a rising trend in water-pipe use among adolescents. It is hoped to get updates of trends from the ongoing Demographic Health survey.
