Trends: Use of cigarettes has decreased slightly during the past 5 years, from 9% to 6% among women and from 30% to 27% among men. (NDHS-2016)  
NDHS- 2016, have reported as follows: Age-standardized prevalence of current tobacco use among persons aged 15 years and older in males is 27.2 and females is 5.8. Among the male population 17% are daily smokers while 11% are occasional smokers.

There are five regional health directorates, 77 district health offices with one health education officer responsible for health promotion and education including tobacco control activities and three types of health care services at village level provided through primary health care centres, health posts and sub-health posts. Tobacco Control and regulatory Act,2011, Tobacco Product Control and regulatory Directive 2015, established the Tobacco Products Control and Regulatory Committee under the chairmanship of the Secretary of the MOHP.
