A new regulation on display of health warnings to the Seychelles National Tobacco Control Act 2009 has been finalized and published in the Gazette in November 2015. The regulation requests that all cigarette packets have pictorial health warnings that cover at least 50% of each of the two main sides of the packet as from 1st December 2016.
