- 1) The lack of manpower focus on tobacco control activities especially at local level. This is a main limitation on implementing the Convention effectively.
- 2) Though there are several innovative means to reduce secondhand smoke, the finding from the latest survey revealed that the exposure rate still high. The reason could be from less recognition on the impact of exposure to secondhand smoke on health, budget constraint to raise social awareness through regular mass media and various campaign activities.
- 3) Most current smokers are not interested in quitting. Even cessation services available on the health care facilities, those did not visit in any health care facilities did not receive the cessation service.

E4. What, if any, are the constraints or barriers, other than lack of resources, you have encountered in implementing the Convention?

Article 5.3: (1) Inconsistent campaign activities which supposed to be done continuously to educate the public and (2) even though ministerial notification in preventing the interference on tobacco control policy has been enacted, it covers only government officers.
