B115. Please provide a brief explanation of the trend in smoking prevalence in the adult population in the past two years or since submission of your last report.  
This Report uses the most recent data on tobacco use in Tonga which is the Tonga STEPS Survey conducted in 2012 and reported in 2014. We can make explanation on the trend in comparison with the STEPS Survey conducted in 2004 (already reported in previous Reports). So, the trends in comparison with the STEPS 2004, there is a minimal reduction in the prevalence of current smoking from 31% to 29.3% in 2004 for both male and female, and from 27.6% to 26.7% for daily smoking. There is no significant difference in the number of male smokers on a daily basis (42.1% in 2012 and 41.9% in 2004) as well as in female smokers (12.4% in 2012 and 13.8 in 2004).

Remains the same as the last report submitted in 2016: According to the STEPS 2012 (reported in a 20-year categories), the highest prevalence was in 45-64 aged males with 49% smoking, and in 25-44 aged females with 16% smoking. Whereas in STEPS 2004 (reported in a 10-year categories) the highest prevalence was in 55-64 aged males with 61%, and in 25-34 aged females with 17%. To sum up, there is a decrease in the overall prevalence of smoking in both sexes across age groups.

It has a multi-sectoral and multi-disciplinary membership and has been advised and supported by four advisory committees for Healthy Eating, Physical Activity, Tobacco and Alcohol. The membership of these advisory committees is made up of representatives from government, the private sector, NGOs, and civil society to engender a whole of society and people-centered approach to NCDs prevention and control. Tobacco Advisory Committee is chaired by the Secretary General of the Tonga Red Cross Society with members include representatives from Ministry of Health and Tobacco Control Unit, Finance and National Planning Department, Ministry of Police, Ministry of Revenue and Customs, Port Authority, Crown Law Department, Statistics Department, National Church Leaders Forum, Salvation Army, Tonga National Youth Congress and Tonga Health.

Over the past two years since the last report submission in 2016, there has been better coordination and active collaboration from all sectors involved in terms of responsibility and roles they played in the national tobacco control coordination and management levels. There were more funding secured from Tonga Health as the primary donor for implementation of the national strategy including tobacco control, and also better coordination of the implementation of the national Strategy. There is also strong political support from government that allows consistent increases in tobacco taxation more recently. Also support from Church Leaders in enforcement of the tobacco free places in church facilities.

The Tobacco Control Unit is under the leadership of the Chief Medical Officer of the Public Health Division of the Ministry of Health, and the management of the Head of the NCD-Health Promotion Unit of the Public Health Division. It has 4 full time working staff with 1 as a senior tobacco control officer responsible for planning, development and coordinating the implementation of the Units annual work plan, 1 as an authorized enforcement officer responsible for the enforcement of the Tobacco Control Act, and two are cessation officers that responsible for conducting quit counseling and provide cessation services for smokers who want to quit. Two of these officers were recruited under contract funded by DFAT, and one of them already absorbed into the Ministry of Health as established staff with the other one's post is still in process.

The amended Tobacco Control Act 2014 was put into force in Feb 29th 2016. It has been amended to improve the effectiveness of existing legislation to curb the widespread use of tobacco products, to reduce exposure to secondhand smoking and to reduce the appeal of smoking to young people. It also includes complete banning (100%) of smoking in all licensed premises with owners are liable to heavy fines for failing to protect people from cigarette smoke on their premises. Authorized officers have been empowered to issue on-the-spot fines of 100TOP for individuals who smoke in smoke free areas, along with further fines if violators fail to provide information or comply with directions given by the officers.
