The amended tobacco control law 2013 also endorsed NTCC as the focal institution for tobacco control in Bangladesh. Moreover in Health, Population Nutrition Sector Development Program (HPNSDP) 2011–2016. Tobacco Control has been taken as an important means of NCD control strategy.

	<p>MOHFW has amended the tobacco control law with the compliance and priorities of FCTC. Smokeless tobacco and pictorial health warning has been included in the law. A draft National strategic plan of action for tobacco control 2014–19 has been developed, which is yet to approve by the ministry. National Tobacco Control Cell (NTCC), MOH&FW has conducted a number of workshops at administrative divisions and districts. Conducting capacity building training for the district taskforce committee members, conducted workshop for Executive Magistrates on law enforcement. A model district and a model upazilla (subdistrict) for Tobacco Advertising, Promotion and Sponsorship (TAPS) ban has been piloted.</p>
