Regarding the 2003., in the Republic of Srpska, the prevalence of young persons as smokers, had decreased from 10.4% to 7.7% in 2008. Primarily, this was influenced by Law on prohibition of sale and use of tobacco products to persons under the age of 18 of the Republic of Srpska.
