	<p>See Annex 3 for some information on health costs related to tobacco.</p> <p>The direct health costs of tobacco use in Cambodia are still difficult to estimate due to inadequate data at present, but the 2009 WHO Country Health Information Profile (CHIP) for Cambodia already lists high blood pressure and heart disease, both known tobacco-related diseases, among the top causes of morbidity and mortality in the country, indicating a significant and growing burden of non-communicable diseases in Cambodia.</p>

Major players include British-American Tobacco (BAT) Cambodia, maker of the popular ARA brand (with a market share of 40.3%), Viniton (28.6%), and Altadis (18.8%). In addition to manufactured cigarettes, hand-rolled cigarettes are also becoming increasingly popular in the country, where one out of three cigarettes consumed is a hand-rolled one. Most of these hand-rolled cigarettes are machine-produced by small-scale producers (British American Tobacco, 2006). Based on the Labour Force Survey in 2000, about 4,739 people are engaged in tobacco manufacturing, including cigarette factories of major brands. More details in Annex 3.

The public lighting tax is used to support public lighting in cities and is imposed on alcohol, soft drinks, and cigarettes; this amounts to 3% tax imposed on cigarette manufacturers. Import duties vary: 7% for cigarettes, 15% for raw material such as tobacco leaves, and 35% for cigars. In addition, Cambodia also has three customs tariff categories, which include Customs Duty (four tariff bands), Special Tax (nine tariff bands), and VAT (one tariff band).)

In this case the “base” is the manufacturer’s price or retail price. If the tax is expressed as an amount (e.g. specific tax), the base of the tax is the volume (number of pieces or by weight) of goods that is taxed. For example, if a tax is US\$ 5 per 100 cigarettes, the amount of tax is US\$ 5 and the base of the tax is 100 cigarettes.

	<p>The total amount of tobacco tax collections by the General Department of Taxation, Ministry of Economy and Finance has increased in the past five years (from USD 5.1 million in 2005 to around USD 13.1 million in 2009), the total government revenue from tobacco taxes only amounted to around 3% and 3.5% of the total tax collected in 2008 and 2009, respectively.</p> <p>Over the last ten years there has been no real increase in taxes on tobacco products.</p>
