La Encuesta Nacional sobre el Uso de Drogas de Estados Unidos de Norteamérica (NSDUH) en el año 2008 estudió la prevalencia de consumo actual, utilizando una definición como la ENSANUT-ECU. En este estudio se evidencia el mismo patrón que la ENSANUT-ECU, en el cual la prevalencia del consumo actual disminuye a medida que aumenta la edad. Por otro lado, son escasos los datos comparables del consumo de tabaco de la población adulta en Ecuador, debido a las diferentes metodologías empleadas. Igualmente, cabe mencionar los datos de la prevalencia actual del consumo de tabaco en la población adulta en el informe de la región de las Américas del 2011, siendo 22,7% el consumo actual.

B123. Please provide a brief explanation of the trend in current smoking prevalence by age group in the past two years or since submission of your last report, if data are available.

Para la población ecuatoriana de 20 a 59 años la prevalencia del consumo actual de tabaco es 31.5%; 38.2% en hombres y 15.0% en mujeres. Pero este dato difiere al considerar la edad. La prevalencia más baja está en el quinto decenio de vida (27.2%) y asciende paulatinamente mientras disminuye la edad, siendo la prevalencia más alta la del grupo de 20 a 29 años (35.5%). Para el sexo masculino la prevalencia encontrada en el segundo decenio de la vida es la más alta, y se diferencia del total de hombres y de las prevalencias encontradas a partir de los 40 años (los intervalos de confianza no se solapan). En el caso del sexo femenino, si bien la prevalencia en los participantes de 20 a 29 años es la más alta del grupo (17.5%), no se diferencia del total de mujeres ni de los demás grupos de edad.

En el estudio Nacional a Hogares sobre Consumo de drogas, se describe una prevalencia de consumo actual de tabaco en el último mes de 18.4%. Como la pregunta se realizó a toda la población, los datos no son comparables (Consejo Nacional de Control de Sustancias Estupefacentes y Psicotrópicas-CONSEP, 2007)

Un denominador similar a la ENSANUT-ECU lo presenta el Estudio Epidemiológico Andino sobre el Consumo de Drogas Sintéticas en la Población Universitaria, en el cual el consumo actual se calcula de los encuestados que refirieron haber consumido tabaco una vez en la vida, y registró la prevalencia de 20.9% para la población de 15 a 34 años, 31.3% en hombres y 11.6% en mujeres (DALENCE ET AL., 2009) Los participantes fueron estudiantes de universidades públicas y privadas de ciudades de 300.000 o más habitantes.

En Ecuador se han realizado en los últimos 10 años al menos siete encuestas sobre consumo de tabaco y alcohol en adolescentes y en adultos jóvenes, las cuales se caracterizan por tener su propia metodología (marco muestral, definición de variables, población de estudio), por lo que las posibilidades de comparación son escasas o nulas. Por ejemplo, la Tercera Encuesta Nacional sobre Consumo de Drogas de Estudiantes de Enseñanza Media (13,15 y 17 años), aplicada a adolescentes que residen en el área urbana y en ciudades de más de 300.000 habitantes, escolarizados que llenaron una encuesta, mostró que el 46.0% ha probado tabaco alguna vez en la vida, 54.8% hombres y 34.8% mujeres (Consejo Nacional de Control de Sustancias Estupefacientes y Psicotrópicas- CONSEP, 2008)

En este sentido, se puede comparar los datos de esta encuesta con la primera y segunda encuesta, puesto que tienen la misma metodología. La prevalencia de vida (consumo alguna vez en la vida) de consumo de cigarrillos tuvo un aumento en el año 2005 pero volvió a bajaren el año 2008. Mientras que la edad de primer uso ha disminuido 1,5 años en 10 años.

El Ministerio de Salud Pública se encuentra desarrollando un documento reporte del consumo de tabaco, trabajado en conjunto con el Instituto de Efectividad Clínica y Sanitaria – IECS de Argentina; sin embargo, a la actualidad no se cuenta con un informe finalizado de la carga estimada que el tabaquismo impone en la sociedad ecuatoriana.

Como parte de ese reporte se estimó el costo del cáncer de pulmón de primer y segundo año y consecutivos, que se construyó en base a una plantilla utilizada en la estimación de costos parte del reporte mencionado.

Sobre la plantilla se realizó una validación de los recursos sanitarios directos identificados para la atención de los diferentes eventos, sus cantidades y tasas de uso mediante consulta con expertos del área de Oncología del Hospital de Especialidades Eugenio Espejo del Ministerio de Salud Pública.

Los costos unitarios de estos recursos fueron extraídos del Tarifario de Prestaciones del Sistema Nacional de Salud versión 2014 [1]. Las tarifas no disponibles desde esta fuente (4%) se estimaron de diferentes formas: a) en base a valores encontrados en internet, mismos que se ajustaron a moneda local con el método del Poder de Paridad de Adquisición; b) estimación del valor del módulo de cuidados paliativos (estimado como precio relativo de Argentina aplicado a Ecuador 62% del costo de la quimioterapia de primera línea).

Los diversos tratamientos farmacológicos comprendidos en el cáncer de pulmón fueron valorados de acuerdo a la Base de Precios oficiales de Medicamentos (abril 2014) [2] de acuerdo a los esquemas planteados originalmente en la plantilla del IECS y validados por los expertos locales.
