The objective of study was to identify and measure the costs (direct and indirect costs) due to alcohol use, smoking, lack of physical activity, inadequate fruit and vegetable intake and overweight to society. The estimation of the economic burden of health risks in Estonia is based on the cost-of-illness (COI) framework and the estimates of the costs are expressed in monetary terms. The base year for all cost calculations was 2006. In order to reach the objective the risk related medical conditions were defined for every separate risk factor, the attributable fractions that associate the exposure of the risk factor and the medical condition were calculated by differentiating for age and gender. For calculating the attributable fractions the relative risks were drawn form scientific literature, but the prevalence of health risks were country-specific. In economic theory as well as in the concept of COI, the economic costs of illness or health risk represent the foregone alternatives and are measured in terms of indirect and direct costs. There is another cost category – intangible cost, which is caused by psychosocial effects of illness. Pain, suffering or other reductions in quality of life are difficult to quantify and therefore are in general excluded from the COI studies. Direct costs are the value of resources used in the diagnosis, treatment and rehabilitation of disease. In this analysis direct costs include expenditures on provided health services (that is hospital and other institutional care, ambulatory services by general practitioners and specialist doctors) financed through the Estonian Health Insurance Fund (EHIF). Direct costs are calculated based on the EHIF database. The present study does not comprise the costs financed from the state nor community budget, including costs for pharmaceuticals and emergency care. The out-of-pocket and employers’ payments are also excluded from this study. The main reason for the exclusion is the lack of reliable data. Two approaches of estimation of the cost of illness exist: incidence and prevalence approaches. The incidence-based cost</p>

	<p>represents the lifetime cost resulting from the illness. To avoid double counting, the health expenditures are allocated by primary diagnosis only.</p> <p>Indirect costs are caused by lost output due to reduced productivity as a result of morbidity and premature mortality. Mortality costs are the value of lost productivity due to premature death resulting from illness. Morbidity costs are the value of lost productivity by persons unable to perform their work or to perform at a level of full effectiveness due to the illness. In order to take into account the impact and the duration of the illnesses on the productivity inclines the disability weights and durations of diseases from the Burden of Disease study of Estonia were used. Lost productivity is calculated according to human-capital approach, which measures the present discounted value of future market earnings lost because of morbidity or premature death. For calculations 3% were used as a discount rate. The lost lifetime earnings were calculated using data from the National Registry of Pension Insurance on national pre-tax wages including the social security tax and unemployment insurance tax for different groups according to age and sex. The market earnings were corrected with the current employment rate for each age and sex group.</p>
