(1) The rate of excise duty on cigarettes consists of a fixed rate per one thousand cigarettes and a proportional rate calculated on the basis of the maximum retail price of the cigarettes. The fixed rate is 275 kroons and the proportional rate is 26 per cent of the maximum retail price of the cigarettes. As of 1 January 2008, the fixed rate shall be 360 kroons and the proportional rate shall be 28 per cent of the maximum retail price of the cigarette.

(2) The rate of excise duty on cigars and cigarillos is 2500 kroons per one thousand cigars or

cigarillos.

(3) The rate of excise duty on smoking tobacco and chewing tobacco is 320 kroons per one kilogram of the tobacco product. As of 1 July 2007, the rate of excise duty on smoking tobacco and chewing tobacco shall be 360 kroons per one kilogram of the corresponding tobacco product and as of 1 July 2008, the rate of excise duty on smoking tobacco and chewing tobacco shall be 400 kroons per one kilogram of the corresponding tobacco product.

Value added tax rate is 18 %.
