3. Close and re-open the WHO FCTC reporting instrument (Microsoft Word-based document which you saved to your computer under step 1).
4. As the document is opening, a box will appear asking if you want to enable macros. The answer is yes. Click "Enable macros".
5. Once you have clicked "Enable macros", the buttons indicating that you can add new rows or new categories to the tables provided will be functional.

If you use a newer version of Microsoft Word:

1. When receiving the security warning "Some active content has been disabled", click "Enable content".
2. When receiving another security warning "Macros have been disabled", click "Enable content".

The prevalence of never smokers increased in men from 46 % to 50 % and in women it again remained on the same level (61 %).</p> |

Among 35-44-year olds the percentage of current smokers decreased slightly from 32 % to 30 %. Prevalence in the 45–54-year old population decreased substantially from 35 % to 27 %. Among 55–64-year olds there was a slight decrease from 24 % to 23 %.</p> <p>Females</p> <p>Prevalence among 25–34 old remained at 29 %. Among 35–44-year olds the percentage of current smokers decreased from 22 % to 18 %. Prevalence in the group of 45–54-year old decreased from 21 % to 18 %. Among 55-64-year olds there was a decrease in prevalence from 16 % to 14%.</p> |

The prevalence has almost doubled in 35–44-year-old men, from 7 % to 13 %. There is a slight increase in the use of snus in 45–55-year olds, from 2 % to 3 %. The prevalence of 55–64-year-old men was 1,4 % in 2008, and in 2013 it was 0 %.</p> <p>Females</p> <p>The prevalence of snus use among females has remained the same through the period. It is very uncommon for adult women to use snus.</p> |

The latest survey was conducted in the spring of 2013 to which a total of 4,158 adolescents responded (44 %). Data presented here originates from this 2013 survey. The survey report "The Adolescent Health and Lifestyle Survey 2013. Adolescent smoking, alcohol and substance use in 1977-2013" is attached to this report instrument. http://urn.fi/URN:ISBN:978-952-00-3306-4</p> <p>Tobacco use in the age group of 19–24 years has not been reported before. The information is derived from the "Health Behaviour and Health among the Finnish Adult Population" (AVTK) -survey which includes results of the spring 2013 data gathering. The data for 19–24-year-olds are not shown on the report, but were calculated particularly for this reporting instrument in order to represent the young adult data. For the 2013 survey, a random sample (n=5000) of Finnish adults aged between 15 and 64 was derived from the Population Register. A questionnaire was mailed in April 2013 with three reminders. The number of respondents was 2545 (response rate 51 %). http://www.thl.fi/avtk</p> |
| 2.1.6.3 | <p>Please provide the definition of “current smoking/tobacco use” used to answer question 2.1.6 in the space below.</p> <p>Current smoking tobacco equals here daily use of cigarettes. To be labelled as daily smoker in 'Adolescent Health and Lifestyle Survey' survey (12–18-year-olds) equals having smoked over 50 cigarettes in lifetime, having smoked during last seven days and smoking at least once a day. Also those who reported smoking "at least once a week, but not daily" but still smoked at least one cigarette per day were labelled into daily cigarette smokers.</p> <p>Smoking status for 19–24-year-olds was acquired by smoking index variable. Derivation of smoking index is described in appendix: "Health behaviour and health among Finnish adult population, Spring 2013". "Current smokers" in question 2.1.6 includes daily smokers.</p> <p>Current smokeless tobacco equals here daily or occasional use of snus (usually Swedish-type moist snuff). To be labelled as current user of snus in 'Adolescent Health and Lifestyle Survey' (12–18-year-olds) equals using snus occasionally or at least once a day.</p> <p>In the "Health behaviour and health among Finnish adult population, Spring 2013" survey (19–24-year-olds) the respondents were asked whether they currently use snus. "Current users" in question 2.1.6 includes daily and occasional users of snus.</p> <p>Total numbers were not presented in the original reports by age groups. Those are calculated to this reporting instrument from the percentages of males and females in each age group.</p> <p>Data regarding current use of other tobacco products than cigarettes and snus among young people in Finland has not been collected on national level.</p> |

Snus use has been increasing among boys since 2007 but the changes between previous data collection (2011) and newest data (2013) were not statistically significant.</p> |

Finland ASH also draws up and releases publications and brochures on tobacco-related issues. Finland’s ASH also carries out and coordinates the activities of the Tobacco-free Finland network which supports the objective of the Finnish Tobacco Act (2010) to put an end to the use of tobacco products in Finland by 2040. The network organizes an annual seminar on topical tobacco issues to the various actors and bodies which are willing to support the aim for Tobacco-free Finland.</p> <p>Finnish Lung Health Association (Filha) has started a peer support based tobacco cessation group therapy project (2013-2015). The project is conducted in collaboration with the Finnish National and local organizations of the unemployed. The first tobacco cessation peer support groups were conducted in 2013 among unemployed and the project is expanding during 2014-2015.</p> <p>Filha has started in 2013 a four year tobacco control project in collaboration with the Defense Forces of Finland. The project aims at influencing attitudes and practices regarding the “tobacco culture” in the defense forces, developing cessation support and knowledge and through these actions decrease tobacco consumption. Filha has conducted nation-wide trainings of health professionals in tobacco dependence treatment best practices ever since the national Current Care guideline first was introduced in 2002. Lately there has been more focus on developing more tailored trainings for example for mental health and maternal and child health as well as surgeons (tobacco free surgery).</p> <p>The Finnish Heart Association has implemented the Smart Family Programme since 2006. Originally, Smart Family provided advice and assistance about healthy lifestyle to families with children (or expecting a child) through public maternity clinics and child health clinics. Initially the focus was mainly on nutrition and exercise. Since 2011, the programme has gradually been extended to elementary schools. In addition, the scope of the programme has been expanded to support smoke-free domestic environments to children and their parents.</p> <p>The Cancer Society of Finland has had programme to reduce smoking among young people (2001-2014). The programme has consisted of seven operative</p> |

elements: communication, cessation, schools, free time, interaction between the youth and adults, Army and research. The awareness raising campaigns have covered several media (tv, radio, Social media) as well as many youth events and facilities. (See also: www.fressis.fi, www.ashbabies.fi, www.tobaccobody.fi, www.tyokalupakki.net, www.smokefree.fi)

North Savo regional Heart Association and University Hospital of Kuopio launched Smoke Free Savo 2015 -program in 2007. The tobacco-free municipalities -project was started in Finland in the year 2012 and is a NGO collaboration project coordinated by the Savo regional Heart Association. The project aims to help municipalities to make decisions to become tobacco-free as well as assisting in the implementation of the decision. The minimum criteria for a municipality are usually that the work-time of the employees is tobacco-free. The project has developed practical tools such as criteria and action plans for a tobacco-free municipality, -workplace and -vocational school as well as tobacco cessation support and introduction of new tobacco dependence treatment methods. At the national level 69 % of all Finnish municipalities have declared themselves as smoke free workplaces (www.savutonkunta.fi).

The tobacco-free municipalities' project was started in Finland in the year 2012 and is a NGO collaboration project coordinated by the Savo regional Heart Association. The project aims to help municipalities to make decisions to become tobacco-free as well as assisting in the implementation of the decision. The minimum criteria for a municipality are usually that the work-time of the employees is tobacco-free. The project has developed practical tools such as criteria and action plans for a tobacco-free municipality, -workplace and -vocational school as well as tobacco cessation support and introduction of new tobacco dependence treatment methods.

The Organisation for Respiratory Health in Finland maintains a tobacco cessation phone line and an Internet portal called Stumppi (www.stumppi.fi). The Internet is constantly updated and renewed when needed and contains a lot of information on tobacco consumption and cessation. The Organisation for Respiratory Health in Finland also coordinates a project to reduce the consumption of tobacco products especially among adult population. Several other NGOs take part in this project. In addition, the Quit and Win competition for smoking cessation has been organized every year in May by the North Karelia Center for Public Health.

Finnish Association for Substance Abuse Prevention EHYT is performing a school-based smoking prevention project SmokeFree which is mainly targeted at pupils and students in lower and upper secondary schools and vocational schools all over Finland. The objectives of the Smokefree are to promote not smoking and not using snus among young people in elementary schools and lower secondary schools.

The class competition is a central and often the best known form of the Smokefree project. Classes commit to not smoking, using snus or electronic cigarettes during the six month competition period. During the latest period in 2013–2014, well over 1300 classes – altogether nearly 23 000 pupils – from all over Finland participated in the competition. Through the Smokefree School activity, Smokefree has distributed financial subsidies to promote wellbeing in schools/educational institutions from the non-smoking viewpoint. Smokefree has also produced materials and training for professionals to be utilized in the prevention of smoking. As an NGO EHYT has also actively participated in domestic public debate and made advocacy.

Through activation of village health committees, primary health care, schools, politicians, and media the project strives to reach better understanding among adults and children of the health hazards of active and passive smoking, to increase the number of smokers who make a quit attempt encouraged by the health care professionals, as well as changes in social norms among adolescents as a results of a novel notion of the successful non-smoker.
