2.1.1.1	<p>Please indicate the smoking tobacco products included in calculating prevalence for question 2.1.1:</p> <p>cigarettes (including roll-your-own),cigars, cigarillos, pipe</p> <p>In the computer assisted telephone interview survey (CATI) „German Health Update“ 2012 (GEDA) we asked adult participants regarding their current smoking behavior: „Do you smoke currently – even if it is just occasionally ?“. Subsequently, all participants who stated that they were current smokers were asked what products they usually smoke: „And what do you smoke specifically? You may give multiple answers“. The following products were presented : „Fully assembled cigarettes“, „self-assembled cigarettes“, „Cigars, Cigarillos“, „Pipes“, „Waterpipes“. Smoking of waterpipe is therefore included in the estimated prevalence of current smoking in the survey GEDA 2012. But, as the first question is not mentioning waterpipes explicitly, it cannot be disregarded, that some users of waterpipes do not consider themselves as smokers and don't consider the second question. Therefore, the prevalence of waterpipe users may be under-estimated.</p>

⁵ The “base of the tax” should clearly indicate the tax rate or amount the tax is based on. If the tax is expressed as a percentage (e.g. ad valorem tax), the base of the tax is the actual value of the good that is taxed; for example, 45% of the manufacturer’s price, 30% of the retail price. In this case the “base” is the manufacturer’s price or retail price. If the tax is expressed as an amount (e.g. specific tax), the base of the tax is the volume (number of pieces or by weight) of goods that is taxed. For example, if a tax is US\$ 5 per 100 cigarettes, the amount of tax is US\$ 5 and the base of the tax is 100 cigarettes.
