	In Italy (crop 2010) there are about 53.000 workers involved in tobacco-growing, plus 5.500 involved in the first processing. In a specific study carried out in 2002 it was showed that the overall breakdown by gender is almost 50/50, while it was dominated by male workers in tobacco growing but in the first processing the female prevalence was around 65%. We estimate that the figures remained the same today.
2.7.3	Please provide, if available, the share of the value of tobacco leaf production in the national gross domestic product. In Italy (crop 2010) the value of the raw tobacco produced was about 196 Million € which represents a minimal share (0,013%) of the Italian 2010 global GDP which was 1.548.816 Million € (both figures are at 2010 current prices). Even tough, in the tobacco growing districts, the production represents a much higher percentage of the local GDP.
