



Prices Ordinance (CAP 75)  
(Section 3(1) and (5))  
**PRICES (AMENDMENT) ORDER (No.09) OF 2013**

In exercise of the powers conferred by Section 3(1) and (5) of the Prices Ordinance (Cap 75),  
I hereby make the following Order:

**Short Title:**

1. This Order may be cited as the Prices (Amendment) Order (No.09) of 2013.

**Commencement:**

2. This Order shall be deemed to come into operation on the <sup>ca</sup> 3<sup>rd</sup> Day of August, 2013.

**Sale of commodities upon immediate payment of prescribed price:**

3. Wholesalers and Retailers having commodities available shall not, except with reasonable cause, the onus of proving which shall be upon such wholesaler and retailer, refuse to sell them to any person tendering immediate payment at the price not exceeding the prices stipulated by the order.

**Amends Parts I and II of the Schedule to the Prices (Regulation) Order (No.01) of 2013**

4. Parts I and II of the Schedule to the Prices (Regulation) Order (No.1) of 2013 is here by amended by deleting and inserting the wholesale and retail prices referring to **Rice, Sugar, Tobacco & Oil no.50** with the following new prices:
