табак для кальяна, также как курение через кальян регулируется национальным законодательством, однако исполнение не удовлетворительное, так как слово "кальян" не было включено в национальный закон, что является основанием для лобби,

бездымное табачное изделие - насвай должен также облагаться налогами, однако фискальные органы до сих пор не могут внести изменения , так как еще не нашли пути их администрирования из-за отсутствия легального производства, что требует законодательно запретить обращения насвая на территории Кыргызстана, однако потребители и сельскохозяйственные производители выступают против, что требует изучения опыта других стран.
