	Tobacco smoking is highly prevalent among Lithuanian population. In 2010 34.2% of men and 14.4% of women were daily smokers, 19.6 and 11.5 % ex-smokers, 30.4% and 62.2 - non smokers. The prevalence of smoking among Lithuanian Adult population had been increasing up to the year 2000. Among women it had increased by 2.3 times. In 2002 the proportion of smoking men started to decline reaching 1.5 fold lower rates in 2010 compared to that 1994. Since 2000 smoking prevalence among women has remained stable. Total (males and females in age group 20-64) daily smokers 2008 - 24.2%, 2010 - 21.8%.

If the tax is expressed as a percentage (e.g. ad valorem tax), the base of the tax is the actual value of the good that is taxed; for example, 45% of the manufacturer’s price, 30% of the retail price. In this case the “base” is the manufacturer’s price or retail price. If the tax is expressed as an amount (e.g. specific tax), the base of the tax is the volume (number of pieces or by weight) of goods that is taxed. For example, if a tax is US\$ 5 per 100 cigarettes, the amount of tax is US\$ 5 and the base of the tax is 100 cigarettes.

	Over the past two years the excise duty rate for tobacco products was increased as follows: For cigarettes from 2011-01-01 the minimum requirement for the overall excise duty (LTL221) was introduced. As well from 2012-03-01 the specific excise duty rate was increased from LTL 132 until LTL 140 and the minimum requirement-from LTL 221 until 232 per 1000 cigarettes. From cigars and cigarillos: from 2011-01-01 the excise duty rate was increased from LTL 38 until LTL 80 per kilogram of the product and from 2012-03-01 - until LTL 84 per kilogram of the product. For other smoking tobacco - from 2011-01-01 the excise duty rate was increased from LTL 111 until LTL 139.
