B115. Please provide a brief explanation of the trend in smoking prevalence in the adult population in the past two years or since submission of your last report.
A systematic survey has not been conducted after the STEPS survey in 2011. However, trends in the Global Youth tobacco survey from 2007 to 2011 show rising trends. Therefore it is suspected that smoking rates are rising, particularly among youth and women.. Meanwhile, Water-pipe is being promoted heavily as 'traditional' among locals (particularly adolescents and women) and tourists. There seems to be a rising trend in water-pipe use. It is hoped to get updates of trends from the ongoing Demographic Health survey.

Smoking is somewhat commoner among older women. Data is currently inadequate for trends, as a systematic survey has not been conducted after the STEPS survey in 2011. However, trends in the Global Youth tobacco survey from 2007 to 2011 show rising trends. Therefore it is suspected that smoking rates are rising, particularly among youth and women. Meanwhile, Water-pipe is being promoted 'traditional' among locals (particularly adolescents and women) and tourists. There seems to be a rising trend in water-pipe use among adolescents. It is hoped to get updates of trends from the ongoing Demographic Health survey.
