Los sistemas electrónicos de administración de nicotina, en especial el denominado "cigarro electrónico", está actualmente prohibidos en nuestro país. Sin embargo en 2015, prosperó el amparo de un particular contra dicha prohibición y logró un veredicto favorable en una de las Salas de la Suprema Corte de Justicia determinó anticonstitucional el artículo de la Ley General para el control del Tabaco que prohíbe la venta y comercialización de este producto. Esta resolución sólo ha sido a favor de un particular, sin embargo, si exhorta al legislativo a modificar la ley, para permitir el "mismo trato" que se le da al tabaco convencional.
