Smuggling of tobacco has remained a low-level but persistent problem for Customs in different forms for many years. That said New Zealand has not seen the regular large container-size interceptions of cigarettes that many other countries are experiencing and it is thought that the market share of illicit tobacco remains below the levels encountered in other countries in the Asia Pacific region.</p> <p>The current New Zealand illicit tobacco market is believed to be fuelled by:</p> <ul style="list-style-type: none"> <li>• small scale importations by passengers exceeding their concession allowance (either unwittingly or as a calculated risk), for personal use. The overwhelming majority of seizures are made at the airports, from incoming air travellers. The tobacco products seized appear to have been legitimately sourced.</li> </ul>
