3. Close and re-open the WHO FCTC reporting instrument (Microsoft Word-based document which you saved to your computer under step 1).
4. As the document is opening, a box will appear asking if you want to enable macros. The answer is yes. Click "Enable macros".
5. Once you have clicked "Enable macros", the buttons indicating that you can add new rows or new categories to the tables provided will be functional.

	Recent developments concerning tobacco taxation resulted in the complete abandonment of any excise tax on tobacco products and reduced the overall total tax and tariff incidence on cigarette consumer prices. Sierra Leone is not compliant with the requirements of Article 6.2 (a) of the Convention, in spite of the fact that increased tobacco taxation is one of the most effective demand side measures, which can bring down tobacco consumption particularly among the poor and the youth.

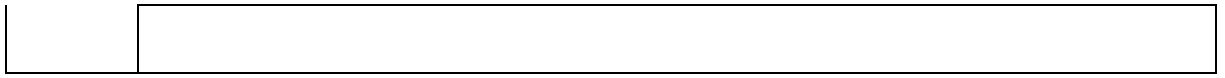
