B115. Please provide a brief explanation of the trend in smoking prevalence in the adult population in the past two years or since submission of your last report.
El último informe de España se basó en los datos de la Encuesta Nacional de Salud 2011 (ENSE 2011) que incluía población de 15 y más años.
En 2014 se observa una reducción global de la prevalencia de fumadores actuales de dos puntos porcentuales (25,4% en 2014 frente al 27% de 2011), disminución algo inferior que en periodos anteriores. En hombres, con consumo de tabaco más elevado tradicionalmente y al contrario que en el periodo anterior, la reducción de la prevalencia ha sido menor proporcionalmente (del 31,4% en 2011 al 30,4% en 2014). En mujeres, esta reducción del consumo actual ha sido mayor (del 22,8% en 2011 al 20,5% de 2014).
De forma similar ocurre con la prevalencia de fumadores diarios, donde se ha dado una reducción global del 24% de 2011 al 23% de 2014, también más elevada en mujeres que en hombres.
La prevalencia de fumadores ocasionales ha disminuido ligeramente, de forma similar en ambos sexos.
El porcentaje de exfumadores ha aumentado en el periodo 2011-2014 en seis puntos porcentuales, en ambos sexos, aunque proporcionalmente más en mujeres. Consecuentemente, se observa una mayor tasa de abandono (exfumadores/fumadores +exfumadores) en 2014 respecto al periodo anterior.
La prevalencia de personas que no han fumado nunca es del 49% en 2014, dándose una reducción respecto a 2011(53,5%), disminución similar en ambos sexos.
La media de cigarrillos consumidos al día por fumadores diarios se ha reducido ligeramente a nivel global (de 13,8 a 13,2 cigarrillos/día entre 2011 y 2014 respectivamente), el descenso ha sido proporcionalmente mayor en hombres.

A nivel global se ha dado una reducción de la prevalencia de consumo de tabaco en todos los grupos de edad hasta los 54 años, sobre todo en mujeres.

El grupo que ha presentado una mayor disminución de los fumadores actuales ha sido el de adultos jóvenes de 15 a 24 años (reducción global del 5%), siendo mayor en mujeres (disminución del 7%, pasando de 24,9% al 17,8%) que en hombres (reducción del 3%, de 27,8% a 25,1%).

El consumo ha aumentado ligeramente a partir de los 55 años de edad, afectado por el aumento en la prevalencia en mujeres en esos grupos, especialmente de 55 a 64 años.

Se presentan y comentan los datos de las dos últimas encuestas ESTUDES publicadas, de los años 2012 y 2014, ya que en el cuestionario anterior sólo estaban disponibles los datos de 2010.

La progresión de la prevalencia de consumo en este periodo ha presentado un cierto repunte en 2012 (mayor en hombres), para posteriormente volver a disminuir en 2014. Esto se observa también en otros indicadores de consumo (diario, en los últimos 30 días) y en ambos sexos, aunque destaca especialmente la reducción global del periodo en mujeres, que aún en 2014 presentan un consumo más elevado que los hombres pero las diferencias se han acortado (29,6% hombres y 33,2% mujeres entre los estudiantes 14-18 años habían fumado en los 12 meses anteriores).

El consumo diario entre los jóvenes aumentó en 2012 al 12,5% (12% en hombres y 13,5% en mujeres) y posteriormente volvió a disminuir notablemente en 2014 (al 8,9%).

De forma análoga, ocurrió con el consumo de tabaco en los 30 días anteriores, siendo del 29,7% en 2012 y del 25,9% en 2014.

A diferencia de los datos aportados en periodos anteriores, la EESE2014 sólo recoge una pregunta sobre exposición al humo: ¿Con qué frecuencia está expuesto/a al humo del tabaco en lugares cerrados? referida a la exposición al humo del tabaco en casa, en el trabajo, lugares públicos, restaurantes...

Esto dificulta la comparación directa con los datos de las encuestas anteriores.

Por otro lado, la EESE 2014 sólo incluye población de 15 y más años, por lo que no podemos disponer de información sobre la exposición en menores de esta edad.

Comparando con los datos previos (Encuesta Nacional de Salud en España 2011), en 2014 se observa cierta disminución de la exposición. Así, la exposición al humo en sitios cerrados habría pasado del 10,8% en 2011 al 8,1% en 2014. Esta reducción se observa en ambos sexos. Se debe tener en cuenta que la recogida de esta variable ha cambiado y podrían no ser completamente equivalentes.

La reducción más destacada en la exposición al humo de tabaco se dio tras el cambio legislativo introducido en 2011, especialmente en los espacios y transportes públicos cerrados y el lugar de trabajo, áreas reguladas por la ley.

A efectos de comparación con el periodo anterior, se han considerado MUERTES ATRIBUIBLES AL CONSUMO DE TABACO las defunciones por CÁNCER PULMÓN (ya que el 90% se deben al tabaquismo), obtenidas del informe de Patrones de mortalidad en España, 2012. Por otro lado, se ha publicado el estudio "Impacto del consumo de tabaco sobre la mortalidad en España en el año 2012", que incluye muertes por otras enfermedades atribuibles al tabaquismo y se comenta más adelante. Muertes atribuibles al tabaco (cáncer de pulmón): 21.511 muertes por cáncer de pulmón (17.683 en hombres y 3.828 en mujeres). La tasa de mortalidad ajustada por edad por cáncer de pulmón en 2012 fue de 33,6 muertes por 100.000 habitantes (60,4 en hombres y 11,6 en mujeres). En 2012 se produjeron 414 muertes por cáncer de pulmón más que en 2011 y 756 más que en 2010.

La evolución de las tasas de mortalidad ajustadas por edad muestra una diferente tendencia en hombres y mujeres. Entre 2001 y 2012 la tasa mortalidad ajustada por edad por esta causa de muerte atribuible al tabaquismo ha descendido 13,2% en hombres, mientras que ha aumentado 68,1% en mujeres. Como consecuencia de esta diferente tendencia, la tasa de mortalidad ajustada por edad pasó de ser 10 veces más alta en hombres que en mujeres en 2001 a 5,2 veces más alta en 2012.

Por otro lado, considerar sólo las muertes por cáncer de pulmón podría infravalorar la mortalidad atribuible al consumo de tabaco. El estudio "Impacto del consumo de tabaco sobre la mortalidad en España en el año 2012" calcula la MORTALIDAD ATRIBUIBLE AL CONSUMO DE TABACO a partir de una metodología análoga a la de otros estudios: utilizando la estimación de la prevalencia de tabaquismo, la mortalidad en la población de 35 y más años, y los riesgos relativos de muerte para cada enfermedad relacionada (neoplasias, enfermedades cardiovasculares y enfermedades respiratorias), según sexo, obtenidos por Thun et al. (JAMA. 2000;284: 706-12), basados en el estudio Cancer Prevention Study II. Según esta investigación, el tabaquismo provocó 60.456 muertes en 2012 (45.669 muertes en hombres y 14.787 en mujeres) . El 15,23% de las muertes ocurridas en España en 2012 son atribuibles al consumo de tabaco. El cáncer de tráquea-bronquios-pulmón en varones y otras cardiopatías en mujeres fueron las que más contribuyeron a dicha mortalidad. Los años potenciales de vida perdidos fueron 184.426, y la media de años potenciales de vida perdidos fue de 3,25 años en varones y de 2,42 en mujeres.

Si consideramos todas las MUERTES RELACIONADAS CON EL TABACO: el informe Patrones de mortalidad en España incluye los siguientes códigos de la 10ª revisión de la Clasificación Internacional de Enfermedades: C00-C14, cáncer de labio, cavidad bucal y faringe; C32, cáncer de laringe; C33C34, cáncer de tráquea, bronquios y pulmón; C15, cáncer de esófago; I20-I25, enfermedad isquémica del corazón; I60I69, enfermedades cerebrovasculares y J40J47, enfermedades crónicas de las vías respiratorias inferiores.

Muertes relacionadas con el consumo de tabaco en 2012: 108.289 defunciones (67.320 en hombres y 40.969 en mujeres). La tasa de mortalidad ajustada por edad por muertes relacionadas con el consumo de tabaco en 2012 fue de 132,3 muertes por 100.000 habitantes (207,3 en hombres y 73,1 en mujeres).

La tasa de mortalidad ajustada por edad por estas causas de muerte experimentó una reducción del 28,2% hombres y del 31,5% en mujeres entre 2001 y 2012. Sin embargo, este indicador sobrestima la importancia de este factor de riesgo en la mortalidad y dificulta la identificación de la tendencia de aquellas causas de muerte más fuertemente relacionadas con el consumo de tabaco.

Se analizaron 500 pacientes, el 50% fueron fumadores; 74% (372) hombres, 26% (128) mujeres. Los pacientes fumadores utilizaron más recursos sanitarios, consumieron más fármacos y tuvieron más días de baja laboral que los no fumadores. Los costes directos e indirectos en fumadores fueron respectivamente 848,64 euros (IQ 25-75: 332,65-1517,10) y 2.253,90 (IQ 25-75: 1.024,50-13.113,60); y en no fumadores 474,71 euros (IQ 25-75: 172,88-979,59) y 1.434,30 euros (IQ 25-75: 614,70-4.712,70); ser fumador incrementó más del doble la probabilidad de tener coste sanitario elevado (OR=2,14; IC 95%: 1,44-3,19).

El trabajo presenta algunas limitaciones que es necesario comentar. En primer lugar el hecho de realizarse en atención primaria podría ser una limitación, sin embargo, este ámbito permite extrapolar mejor los datos a población general lo que permite evaluar mejor los costes globales por tabaquismo. Otra posible limitación es la no inclusión de pacientes exfumadores.

2. Se ha desarrollado un proceso formativo on-line dirigido a todos los profesionales de Atención Primaria en metodología del cambio y Educación para la salud relacionada con un estilo de vida saludable, está acreditado y pretende ser un complemento de los programas formativos, que ya desarrollan las comunidades autónomas.

3. Implementación Local de la Estrategia: Se ha firmado un acuerdo de colaboración con la Federación Española de Municipios y Provincias, elaborado una guía y llevado a cabo distintas reuniones para priorizar las actividades dirigidas a mejorar las condiciones y oportunidades que fomentan estilos de vida saludables en las ciudades, entre las temáticas a abordar se incluye la prevención y control del consumo de tabaco. Dentro de dicha implementación local se ha elaborado un mapa de recursos para la salud de los municipios adheridos, donde se pueden consultar, entre otros, los recursos en prevención del tabaquismo a nivel local (<http://localizasalud.msssi.es/maparecursos/main/Menu.action>).

En España, se pueden distinguir dos tipos de apoyo a la diversificación del cultivo del tabaco: ayudas nacionales y ayudas cofinanciadas por Fondo Europeo Agrícola de Desarrollo Rural (FEADER).

1. Ayudas nacionales: Ayudas a la diversificación y dinamización económica de municipios tabaqueros. En 2013, En Extremadura se convocó una ayuda dotada de 8.500.000 euros (Decreto 42/2013, de 26 de marzo, por el que se establecen las bases reguladoras de la concesión de ayudas para la diversificación y dinamización económica de municipios tabaqueros, y se dispone la convocatoria para el ejercicio 2013). El sector primario está excluido de esta ayuda y están incluidos los sectores secundario y terciario. Se han aprobado 228 expedientes.

El 10 de octubre de 2011, se suscribió un convenio de colaboración entre el Ministerio de Medio Ambiente y Medio Rural y Marino y la Consejería de Agricultura, Desarrollo Rural, Medio Ambiente y Energía de la Junta de Extremadura, para la realización de un programa de desarrollo rural sostenible en las comarcas tabaqueras extremeñas. El convenio de suscribió como consecuencia de la inclusión en la Ley 39/2010, de 22 de diciembre, de presupuestos Generales del Estado para el año 2011 como una subvención nominativa, con una dotación de 9.000.000 de euros. A fin de desarrollar las actuaciones descritas en el convenio, la Consejería de Agricultura estableció mediante el Decreto 42/2013, de 26 de marzo, las bases reguladoras para la concesión de ayudas en concurrencia competitiva, para la diversificación y dinamización económica de municipios con clara vocación tabaquera, así como en su área de influencia.

El convenio, con un acuerdo de modificación y prórroga incluido, terminó el 31 de diciembre de 2014, en estos momentos la Comisión de Seguimiento del convenio está gestionando su cierre y liquidación.

Al amparo del convenio se han certificado 167 expedientes suponiendo un gasto con cargo al convenio de 5.705.893,07 de euros, incluyendo una asistencia técnica para la realización, entre otros, de trabajos de apoyo a la gestión de la línea de ayudas a la diversificación y dinamización económica de los municipios tabaqueros con un coste de 259.557,57 euros, la diferencia entre la dotación inicial del convenio (9.000.000 de euros) y la cantidad justificada se devolverá por parte de la Junta de Extremadura al Tesoro Público.

2. Ayudas cofinanciadas por el FEADER: Existen tres programas de desarrollo rural (PDR) FEADER que contienen ayudas a la diversificación del tabaco: Castilla y León, Andalucía y Extremadura.

Andalucía: El Programa de Desarrollo Rural (PDR) de Andalucía, para el marco 2007-2013, recogía la Medida 144 "Explotaciones en proceso de reestructuración con motivo de la reforma de la OCM del tabaco", que tenía como beneficiarios a los tabaqueros que realizaran una diversificación económica hacia otras actividades tanto agrarias como no agrarias. Esta medida tenía una financiación asignada de un gasto público que ascendía a un montante de 1.584.606 euros para el marco 2007-2013.

No obstante, el actual Programa de Desarrollo Rural (PDR) de Andalucía, en su marco 2014-2020, no recoge operaciones específicas destinadas a la diversificación del sector del tabaco.

Extremadura: Los proyectos de diversificación del sector tabaquero se incluyen en el PDR 2007-2013 de Extremadura dentro de la medida 413 (aplicación de estrategias de desarrollo local), que comprendía actividades de diversificación hacia actividades no agrícolas, ayuda a la creación y desarrollo de microempresas y fomento de actividades turísticas. Toda la medida 413 tiene una asignación financiera de 10.607.903 euros (en este montante se incluye tanto las actuaciones dirigidas al sector tabaquero como a otros sectores).

Castilla y León: En el periodo 2012-2014 se apoyó la reconversión de las explotaciones que iniciaran otra actividad con abandono progresivo del cultivo del tabaco.

En la actualidad no se concede ayuda alguna en este ámbito.

Aunque, estas opciones y recomendaciones fueron aprobadas en la COP6 en octubre de 2014 y la última reforma de la PAC, que se ha empezado a aplicar en el año 2015, finalizó su negociación a finales de 2013, con la publicación de la normativa aplicable en diciembre de ese año, la citada reforma recoge aspectos ambientales importantes que afectan a las prácticas agrícolas de los cultivos y, por tanto, al cultivo del tabaco.

Por un lado, con esta nueva PAC (en vigor desde 2015 y hasta el año 2020), se han eliminado las ayudas específicas al cultivo del tabaco, ayudas éstas asociadas a la producción, que sí se podían dar en el anterior periodo de la PAC y que ahora han sido eliminadas para el tabaco específicamente. La eliminación de las ayudas vinculadas puede desincentivar este cultivo, como puede apreciarse en su evolución a la baja en los últimos años, en paralelo a la disminución y desacoplamiento paulatino de las ayudas comunitarias en este sector.

Por otro lado, al tratarse el tabaco de un cultivo en tierra arable, le afecta el cumplimiento de la diversificación de cultivos y de las superficies de interés ecológico, que el agricultor deberá respetar en función de la estructura de su explotación, y que se comentan en el apartado C413. En concreto, la práctica de diversificación está encaminada a romper la práctica del monocultivo, por lo que el agricultor está obligado a diversificar sus producciones y a buscar alternativas al mismo.

* Dentro del primer pilar de la política agraria comunitaria (PAC):

En el marco de los pagos directos, la última reforma de la PAC da una mayor importancia a la sostenibilidad medioambiental de la agricultura dentro del primer pilar de la PAC, en la UE.

Así, esta nueva PAC dentro de los pagos directos, ha introducido un nuevo pago denominado “Pago para prácticas agrícolas beneficiosas para el clima y el medio ambiente” (conocida comúnmente como “greening” o “pago verde”). Este pago es obligatorio para los agricultores y cuenta con una dotación presupuestaria de un 30% del sobre nacional de cada Estado miembro, de la UE, dentro de los pagos directos. Se concede un pago anual por cada hectárea admisible, siempre que se respeten determinadas prácticas medioambientales, dependiendo de la estructura de la explotación. Así, los agricultores con derecho a un pago en virtud del “régimen de pago básico” deben respetar dichas prácticas en todas las hectáreas de su explotación.

Se consideran prácticas beneficiosas para el clima y el medio ambiente: la diversificación de cultivos, el mantenimiento de los pastos permanentes existentes y contar con superficies de interés ecológico en la explotación (barbecho, superficies dedicadas a cultivos fijadores de nitrógeno, superficies forestadas y superficies dedicadas a agrosilvicultura). Estas prácticas de “greening” buscan mejorar el comportamiento ambiental y de cara al cambio climático de las explotaciones.

Al tratarse el tabaco de un cultivo en tierra arable, le afecta el cumplimiento de la diversificación de cultivos y de las superficies de interés ecológico, que el agricultor deberá respetar en función de la estructura de su explotación. En concreto, estas dos prácticas van dirigidas directamente a la mejora del suelo y a la biodiversidad, con efectos también en lo que tiene que ver con la mitigación del cambio climático.

* Dentro del segundo pilar de la PAC:

En Extremadura (principal región productora de tabaco en España, con el 95,38% de la producción total), en el marco de su PDR, existe una medida agroambiental que favorece la producción integrada de tabaco, haciendo este cultivo más sostenible desde el punto de vista medioambiental.

Tanto su comercialización como su consumo son marginales. Durante el año 2014 se experimentó un auge de la oferta de dispositivos SEAN en tiendas especializadas que posteriormente se ha reducido mucho en 2015 al no ser respaldado por el consumo de la población.
Se han establecido limitaciones específicas para estos dispositivos en relación a su consumo en determinados espacios como son los centros y dependencias de las Administraciones públicas, los centros, servicios y establecimientos sanitarios, en los centros docentes y formativos, en los medios de transporte público urbano e interurbano y en los recintos de los parques infantiles. También se han establecido una serie de limitaciones a la publicidad en función de su horario de emisión en los medios de comunicación o de su población de destino y con el objetivo de la protección de los menores.
