2.1.1.5	<p>Please provide a brief explanation of the trend in smoking prevalence in the adult population in the past two years or since submission of your last report.</p> <p>[ In Tajikistan the situation with tobacco use is mixed. In overall, the rate of smoking cigarettes seems to be low; however the share of people using chewing tobacco (locals name it as nasway) is increasing lately. The latest national survey on tobacco use by youth conducted in Tajikistan was in 2004, the Global Youth Tobacco Survey (GYTS) which was Central Asia multicountry survey. This survey revealed that in Tajikistan only 5.9% of students used any tobacco products (boys = 6.8%, girls = 2.8%) whereas the results of other countries were higher (7.9%). For example, in Kyrgyzstan it was 7.2% (boys = 10.8%, girls = 4.8%) and in Kazakhstan - 11.3% (boys = 13.8%, girls = 9.0%). Since that time there has not been carried out any national use either on tobacco use by youth or adults in Tajikistan. However, National Statistic Agency is going to include tobacco use questions into household survey in 2014. Furthermore, within the monitoring and evaluation (M&amp;E) framework of the national health strategy for 2010-202 (NHS) the MOH&amp;SPP has included an indicator related to prevalence of smoking as reducing of mortality from NCD causes is one of the main priority of the NHS.</p> <p>According to the recent rural population survey (2009-2010), the prevalence of smoking cigarettes among men was 8.7% and women – 0%, and the prevalence was observed among age group 25-54 years old (12-14%) while among younger population group only 2.7% reported about smoking habit. However, the results of this study revealed another tendency – a chewing tobacco (locals name it as nasway) mostly popular among Tajik population. About, 40% of rural men and 3% of rural women reported that they use nasway. It is more prevalent among older women (45-59 years old) – 7-8%, while it is much lower among younger women. Among youngest men (15-24 year old) only 9% reported using nasway, while 60% of male respondents in the age group 45-54 year old used it. Possible explanation of this could be the cost, i.e. the price of nasway is extremely low – 50 gr. -50 diramme (0.1USD) whereas the price of one pack of cigarettes is about 3-6 somoni (0.6-1.3USD). Similar survey was conducted among urban population in 1998-2003 . This survey revealed that 30.1% among men and 2.5% among women smoke cigarettes whereas 23.4% and 1.2% use “nasway” accordingly.</p>

If the tax is expressed as a percentage (e.g. ad valorem tax), the base of the tax is the actual value of the good that is taxed; for example, 45% of the manufacturer’s price, 30% of the retail price. In this case the “base” is the manufacturer’s price or retail price. If the tax is expressed as an amount (e.g. specific tax), the base of the tax is the volume (number of pieces or by weight) of goods that is taxed. For example, if a tax is US\$ 5 per 100 cigarettes, the amount of tax is US\$ 5 and the base of the tax is 100 cigarettes.

2.8.7	<p>Please indicate the year and source of the data used to answer questions 2.8.1 to 2.8.6:</p> <p><b>Министру финансов Республики Таджикистан</b></p> <p><b>21 июня 2013 года Таджикистан ратифицировал Рамочную Конвенцию ВОЗ по борьбе против табака (РКБТ ВОЗ), и она официально вступила в силу для страны 19 сентября 2013 года.</b></p> <p><b>В Статье 6 РКБТ ВОЗ «Ценовые и налоговые меры по сокращению спроса на табак» стороны признали, что ценовые и налоговые меры являются эффективным и важным средством сокращения потребления табака различными группами населения, особенно молодежью, и что каждая страна, ратифицировавшая РКБТ, должна осуществлять такую налоговую политику в отношении табачных изделий, которая приводит к сокращению их потребления.</b></p> <p><b>По данным международных исследований налоговая политика приводит к сокращению потребления табачных изделий только в том случае, если цены на них растут выше уровня инфляции. Индекс потребительских цен в Таджикистане в 2009-2012 годах на все товары (инфляция) составил 134%, а на табачные изделия – 106%, то есть произошло снижение реальных цен на табачные изделия, что могло вызвать рост их потребления. Такая ситуация была вызвана тем, что в Таджикистане с марта 2010 года не пересматривались ставки акцизов на табачные изделия.</b></p> <p><b>В настоящее время эти ставки существенно ниже, чем во всех соседних странах (Таблица). С января 2014 года ставки акцизов на сигареты вырастают в Казахстане и Кыргызстане в 2 раза, в России – на 42%. Ставки акциза в Таджикистане будут в 4-27 раз ниже, чем в соседних странах.</b></p> <p><b>Таблица. Низкая ставка акциза на табачные изделия также не позволяет получать дополнительные поступления в бюджет Таджикистана. Опыт других стран показывает, что значительный ежегодный рост ставки акциза на табачные изделия существенно повышает доходы бюджета даже при сокращении их реализации. Например, в Украине в 2007-2012 годах доходы бюджета от табачных акцизов выросли с 2,5 млрд. гривен до 16,6 млрд. гривен при снижении реализации табачных изделий на 30%. В Узбекистане в 2009-2011 годах доходы от табачных акцизов выросли с 66 млрд. сум до 95 млрд. сум при снижении реализации табачных изделий на 10%.

В настоящее время ставка акциза на 1000 сигарет с фильтром составляет 0,85 евро, то есть акциз на пачку сигарет составляет всего 0,11 сомони и почти не влияет на их конечную цену. Предлагается выразить ставку акциза не в евро, а в национальной валюте сомони, и установить ее на уровне 20 сомони на 1000 сигарет с фильтром. Ставки акциза на другие табачные изделия изменить пропорционально.

В случае принятия данного предложения ставка акциза останется более низкой, чем в любой стране Средней Азии (Таблица) и будет в 7,5 раз меньше, чем в России. Акциз на пачку сигарет вырастет всего на 0,29 сомони, но в таком случае цены на сигареты вырастут на 10-20%, что приведет к снижению их потребления и будет способствовать улучшению здоровья населения Республики Таджикистан.

Importantly to note, excise tax on cigarettes has not been revised since 2010 despite of that the new Tax Law were introduced in 2013. In 2013 minimum excise taxes per 1,000 filter cigarettes was 0.85 euro whereas in Kyrgyzstan – 2.6 euro and in Ukraine - 20.7 euro.
