	There is a reduction in the prevalence of tobacco smoking since the submission of the last report in 2012. In comparing the prevalence of 2011 Census with that of 2006 Census (used in the last report), there was a decrease by 1.6% in the total prevalence of both sexes (28.7% in 2006 to 27.1% in 2011). Same trend is seen in male with a decrease from 45.8% to 43.2% and very marginal decrease from 11.6% to 11.3% in female.

It has a multi-sectoral and multi-disciplinary membership. This national NCD Governance Body has 4 working hands (sub-committees) for the four key risk factors of NCD namely: 1. Healthy Eating Subcommittee (SC), Tobacco Control SC, Physical Activity SC and the Alcohol Control SC. The focal point is the Chief Medical Officer of the Public Health Division of the Ministry of Health, and the Tobacco Enforcement Unit is also under the leadership and management of the Chief Medical Officer of the Public Health, Ministry of Health.</p>

	<p>The national coordination mechanism for NCD including Tobacco Control has been undergoing extensive revising and restructuring at both governance and operational levels. The draft of the new governance structure is yet to be finalized and approved by Cabinet. This new structure includes a secretariat body to coordinate the allocation of funds and oversee the implementation of approved NCD related activities and to report to the National NCD Committee and Cabinet. The establishment of the Tobacco Enforcement Unit is another milestone to strengthen the enforcement of Tobacco Act accordingly. Litigation of non-compliance people to the ACT have been done in the Court of Law with more people found guilty and penalized up to TOP\$3000 for selling single/loose cigarettes, and selling to minors.</p>
