	Since 2006, when the previous HBSC was conducted, tobacco use declined among 11 and 13 years old boys and girls, while there were little changes among 15-years old. There were also no big changes in 2007-2011 for 15-16 years old by ESPAD data.

	Among adults in the Ukraine in 2010 30.6% were living in homes where smoking was allowed. 34.0% adults were exposed to SHS in the past month at their indoor workplace. For specified locations, exposure to SHS was lowest in health care facilities (6.6%); however, exposure was 64.1% in restaurants or cafes. Overall since 2005 to 2010 proportion of those who were exposed daily or almost daily decreased from 53% to 33%, and the proportion of those almost never or rarely exposed increased from 26% to 48%. In this case the “base” is the manufacturer’s price or retail price. If the tax is expressed as an amount (e.g. specific tax), the base of the tax is the volume (number of pieces or by weight) of goods that is taxed.
