B115. Please provide a brief explanation of the trend in smoking prevalence in the adult population in the past two years or since submission of your last report.

Data from the IHS show a year on year decrease in the prevalence of adult smokers in England from 20.1% in 2010/11 to 19.8% in 2012/13 to 18% at the end of 2015. Prevalence has also been seen to decrease in pregnant women from 14% in 2010/11 to 11% at the end of 2015 (Women's Smoking Status at Time of Delivery, England HSCIC)

Prevalence is also decreasing across the devolved administrations; prevalence in Scotland has reduced from 24% in 2010/11 to 20.3% in 2014. Similarly prevalence in Northern Ireland has decreased from 24% in 2010/11 to 22% in 2014.

Self-reported exposure to second-hand smoke was highest among those aged 16-24, over half of this age group reported at least some exposure. Exposure was most likely to occur in outdoor smoking areas of pubs/restaurants/cafes or at home (including other people's homes). More men than women reported exposure to other people's smoke (31% and 26% respectively).

Overall the mean number of reported hours of exposure per week to second-hand smoke was 3.1 among men and 2.1 among women. Exposure for men has stayed the same since 2011 but for women has decreased from 2.8.

Findings from the Health Survey for England (HSE) showed a marked fall in objective and self-reported measures of exposure to second-hand smoke following the introduction of smokefree laws in 2007.

Cotinine levels less than 12ng/ml were used to measure exposure to environmental tobacco smoke.

In 2013, 78,200 of all deaths in England were attributable to smoking, making up 17% of all deaths in England that year. This figure includes 37,200 deaths from cancers believed to be caused by smoking, meaning that in 2013 approximately 30% of all deaths from cancer were attributable to smoking.

Smoking has been also been attributed to:

- 81 per cent of deaths from trachea, lung and bronchus cancer.
- 79 per cent of deaths from cancers of the larynx
- 66 per cent of deaths from cancers of the oesophagus
- 64 per cent from cancers of the upper respiratory sites

In addition to Cancers, an estimated 85 per cent of deaths from chronic obstructive lung disease were attributable to smoking as well as 59 per cent of deaths from aortic aneurysms.

In 2012/13 there were approximately 1.6 million hospital admissions for adults aged 35 and over with a primary diagnosis of a disease that can be caused by smoking, that's an average of 4,400 admissions per day.

This figure has continued to increase year on year since 1996 when the number of such admissions was approximately 1.1 million. Men accounted for 55% (877,193) of admissions and women accounted for 45% (723,009).

Research carried out by Oxford University estimated that smoking cost the National Health Service in the UK (NHS) £5.2 billion in 2005/06, approximately 5.5 per cent of total healthcare costs. In 2011/12, some 1.6 million hospital admissions in England among adults aged 35 years of age and over were attributable to smoking. Illnesses among children caused by exposure to second-hand smoke lead to an estimated 300,000 general practice consultations and about 9,500 hospital admissions in the UK each year.

According to the Policy Exchange, the costs of tobacco use are much greater than just costs to the NHS, with the overall economic burden of tobacco use to society estimated at £13.74 billion a year. These costs comprise not only treatment of smoking-related illness by the NHS but also the loss in productivity from smoking breaks and increased absenteeism, the cost of cleaning up cigarette butts, the cost of smoking-related house fires and the loss in economic output from people who die from diseases related to smoking or exposure to second-hand smoke.

The Government has continued to implement and deliver against the national ambitions and commitments set out in "Healthy Lives, Healthy People: A Tobacco Control Plan for England". This strategy ran out at the end of 2015, a new Tobacco Control Strategy is under development and will be published later this year. Tobacco Control Strategies have also been published in other parts of the UK, including Northern Ireland and Scotland who have set national 'smokefree' ambitions, by which time they aim for 5% or less of the population to be smoking.

The Tobacco Control Unit has a team dedicated to the implementation of the new Tobacco Products Directive. Work is underway across the UK to transpose this directive ahead of May 2016 and train enforcement staff to enforce the new standards as they come into force.

In March 2015, Parliament passed legislation to introduce the standardised packaging of cigarettes and hand rolling tobacco (HRT) across the UK. This Legislation is due to come into force in 2016.

On the 1 October 2015, the following UK wide legislation was introduced, making it an offence:

- to smoke in a car carrying children
- to sell e-cigarettes to anyone under the age of 18, and
- for adults to buy tobacco or e-cigarettes for those aged under 18

"Healthy Lives Healthy People: A Tobacco Control Plan for England" included a chapter entitled "Protecting tobacco Control from vested interests". Through this plan, the Government committed to delivering further transparency and publishing the details of all policy related meetings between the tobacco industry and Government Departments. This excludes meetings to discuss illicit trade and bilateral meetings between tobacco companies and HM Revenue and Customs. As per FCTC recommendations, face-to-face interactions with tobacco manufacturers are limited to practical matters. Notes from these meetings are published on the DH website.

Public consultation documents concerning Tobacco Control ask all respondents to disclose whether they have any direct or indirect links to, or receive funding from, the tobacco industry. The tobacco industry is purposefully not involved in the development of tobacco control strategies.

Local authorities are encouraged to follow the Governments lead in this area.

In December 2013, The Department of Health held a two day workshop for other government departments on interaction with the tobacco industry. The purpose of the workshop was to raise awareness of the influence the tobacco industry can and has had on policy, to encourage Departments to limit interactions with the tobacco industry and ensure the transparency of those interactions that occur.

Supplementary guidance has been developed to ensure compliance across the Trading Standards Institute ('TSI') and local authority trading standards departments ('TSDs') who have cause to engage with the tobacco industry regarding counterfeit and illicit tobacco.

Over 100 local authorities have also voluntarily signed the Local Government Declaration on Tobacco Control which relates to Article 5.3 of the world's first global public health treaty, the Framework Convention on Tobacco Control. The declaration states that:

"In setting and implementing their public health policies with respect to tobacco control, parties shall act to protect these policies from commercial and other vested interests of the tobacco industry in accordance with national law."

Prisons  
In partnership with the Welsh Government we will begin to implement a smoke free policy in all prisons in Wales (HMPs Cardiff, Parc, Swansea and Usk/Prescoed) from January 2016, and at 4 prisons in England (HMPs Exeter, Channings Wood, Dartmoor and Erlestoke) from March 2016. From now until the smoke free implementation date these prisons will be encouraging and supporting prisoners to stop smoking through a range of smoking cessation support and advice, including nicotine replacement therapy. We will continue to take a sensible and considered approach, using the experience of the first prisons to go smoke free to inform the speed at which we move to smoke free across our remaining prisons.

**NHS Smoking Helpline**

The Government continues to Fund the NHS Smoking Helpline. The helpline offers free help, support and advice on stopping smoking, including when you're pregnant.

**NHS Stop Smoking service**

Local authorities fund free local stop smoking services where smokers can get face to face advice about quitting as well as free NRT. They can offer one-to-one or group sessions with trained stop smoking advisers and may even have a pregnancy stop smoking specialist. They can also offer advice about dealing with stress, weight gain and support the use of nicotine replacement therapy.

**Health Professionals Training**

Training has been rolled out to midwives and health visitors to improve the quality of data and enhancing the knowledge and skills of health professionals to provide effective support for pregnant women who smoke. This has resulted in an increase in routine Carbon Monoxide monitoring of pregnant women and seen smoking prevalence for pregnant women fall to 11%.

**Public Health Campaigns**

January Health harms: In 2013 the Department of Health launched a "health harms" campaign to encourage smokers to quit in the New Year. The campaign aims to increase awareness by highlighting the immediate damage being done by every single cigarette. Smokers will be encouraged to collect a free Quit Kit from their local participating pharmacy to help support their quit attempt. The Health Harms campaign has run each year since 2013. The campaign which included televised adverts key plank of our was to return to health harms advertising. We launched this with our first campaign in support of this strategy - 'mutation' - which showed a tumour developing on a cigarette, with the line 'If you could see the damage, you wouldn't smoke'.

Stoptober: The Government continues to run Stoptober, a 28 day mass participation event to help smokers in the UK quit via a public challenge to stop smoking for the duration of the month of October. The 2014 campaign had over 250,000 participants and was concurrently run in New Zealand and the Netherlands. Social media plays an integral part in this campaign, designed using behavioral economic principles. Participants were supported to quit, receiving a free Stoptober pack with information about the health and financial benefits of quitting smoking.

Smokefree homes and cars campaign: The Smokefree Homes and Cars campaign was first run in 2012, and then again in summer 2013. The campaign achieved the highest campaign awareness since 2005 and successfully changed both attitudes and behaviours around smoking in the home and car, as well as triggering significant numbers of quit attempts. Smokefree Kits further boosted people's chances of quitting successfully.

Regional Groups and Organizations, also run public health campaigns targeted local populations. Smokefreelife Berkshire for example launched a "Stop before the Op" campaign in 2014 to ensure people stay in their best health during and after their operation.

NRT such as patches and gum are also available free of charge from GPs and local stop smoking services. The Medicines and Healthcare Products Regulatory Agency (MHRA) licenced its first e-cigarette in November (2016). It is anticipated that it will be on the market next year and available for local stop smoking services and GPs to prescribe.

All non-licenced e-cigarettes, sold as consumer products will be subject to strengthened regulatory controls under the European EU Tobacco Products Directive from May 2016 and will continue to be available to buy from retailers for smokers who wish to use them to help them quit smoking.

Following a review by the Medicines and Healthcare Products Regulatory Agency (MHRA) in 2005, NRT can now be used by adolescents aged 12 and over, pregnant women and people with cardiovascular disease. NRT is widely available, and sales tax has been reduced to the lowest amount permissible to encourage use.

The Government has undertaken to work in collaboration with the public health community to consider what more can be done to help tobacco users who cannot quit, or who are unwilling to, to substitute alternative safer sources of nicotine, such as NRT, for tobacco. In support of this, the National Institute for Health and Clinical Excellence has produced public health guidance on the use of harm reduction approaches to smoking cessation.

The National Institute for Health Research is currently funding a randomised controlled trial to examine the efficacy of e-cigarettes compared with nicotine replacement therapy, when used within the UK stop smoking service. The report of the trial is expected to be published in 2018.
